




1. Wireless Control

With 433MHz wireless, RC-A5 has control function. Up to 6 groups of LED lights can be controlled. 16 channels are available with strong anti-interference capability.

Please set the channels and groups of LED light to the same as those of RC- A5 remote control before usage.

2. Adjusting Channel/Group with the Remote Control

- Press the CH/GRP button and the group icon blinks.
 Press the"-""+"button to choose a group (A to F)
- ress the CH/GRP button twice and the channel icon blinks.

 Press the "-""+"button to choose a channel (1 to 16).

3. Adjusting Light Brightness with the
